

# **KLE SOCIETY'S LAW COLLEGE INTRA-COLLEGE MOOT COURT COMPETITION – 2019**

## **Moot Court Committee**

### **Rules**

#### **General**

1. The competition is open for all the students of LL.B., B.A.LL.B. and B.B.A.LL.B.
2. The language of the competition shall be English.
3. Problem No.1 shall be for I, II and III year of 3 Year LLB and III, IV and V year B.A.LL.B. and B.B.A.LL.B. students.
4. Problem No.2 shall be for I and II year B.A.LL.B., B.Com.LL.B. and B.B.A.LL.B. students.
5. The competition shall be conducted in three rounds: preliminary, semi-final and final.
6. The last date of registration is 6<sup>th</sup> March 2019.
7. A researcher's test shall also be conducted.

#### **Composition**

1. Each team shall consist of at least two speakers and shall not exceed three members. In case of a three-member team, one of the members shall be the researcher.
2. The students can register either as a team or individually. In case of individual registration, the Moot Court Committee will club the individuals in teams.
3. A team may comprise of students from different classes subject to the eligibility criteria.
4. Each team shall present the arguments representing one of the sides. The teams are not allowed to choose the sides. Sides shall be allotted by the Moot Court Committee.
5. The sides shall be communicated to the teams the following day after the date of registration.

#### **Oral Submission**

1. The oral rounds will take place on 15<sup>th</sup> and 16<sup>th</sup> March 2019.
2. Fixtures will be decided by the Moot Court Committee and communicated to teams along with the team codes on 11<sup>th</sup> March 2019.
3. Each team will get 20 minutes to present its arguments in preliminary round and 30 minutes in semi-final and final rounds. No speaker shall take more than 15 minutes to present his arguments and each Speaker will be assessed individually.

## Written Submission

1. Each team shall submit two copies of memorials before 5.00 pm on 14<sup>th</sup> March 2019 to Moot Court Committee in the Moot Court Hall.
2. The contents of the memorial shall be in the following order:
  - I. Title page
  - II. Contents
  - III. Abbreviations
  - IV. Index of Authorities
  - V. Table of Cases
  - VI. Statement of facts
  - VII. Statement of Jurisdiction
  - VIII. Issues
  - IX. Summary of Arguments
  - X. Arguments Advanced
  - XI. Prayer
3. The memorial shall be typed and printed on one side of A4 size paper with 12 font size with Times New Roman font style and 1.5 spacing. The total number of pages shall not exceed 25 pages.
4. The students may choose any standard form of citation and the same shall be uniformly followed in preparing the memorials.
5. All the participants shall strictly follow the dress code prescribed for advocates, i.e., white shirt, black trousers, formal shoes, black blazers. However, the female participants are allowed to wear Indian formals of white colour with black blazer.

3. Last date of submission of memorials - **14th March 2019**
4. Oral rounds - **15th and 16th March 2019**
